Environmental Activist Xiuhtezcatl Martinez: A Teen on the Front Lines

[...] For hip-hop artist and environmental activist Xiuhtezcatl Martinez, the next 12 months will be nothing short of game changing. Not only is the landmark climate lawsuit he helped bring against the federal government scheduled 1 to be heard in open court in February 2018, but Break Free, his solo record debut, is set for a September release. And his book, We Rise, what he calls a "tool kit" for grassroots mobilizing, is also due this fall. The case rests on the legal argument that climate change threatens the plaintiffs' fundamental constitutional right to life and liberty. Julia Olson, a lawyer for the plaintiffs [a group of 21 young Americans who range in age from 9 to 20] and executive director of Our Children's Trust, argued in court that the federal government has understood the threat of climate change for decades and knowingly put the lives of future generations in danger. The current measures in place to reduce greenhouse gas emissions are insufficient and not aligned with current science, she argued.
